DISCIPLINE

STUDENT ATTENDANCE

Directions: Student attendance should be reported as a percentage and should include the school's total enrollment. The percentage should be calculated for the entire school year. Students who were not present, but who were involved in off-campus, school-related activities are not to be counted in this calculation.

Example: 175 days in the school year X the number of students enrolled on the last day of school = total possible number of days attended by all students. The total number of student absences for the school year divided by the total possible number of days attended by all students = the percentage of absences. 100% minus the percentage of absences = the percentage of student attendance.

STUDENT MOBILITY

Directions: Student mobility is calculated, for the entire school year, using the following formula:

All Student Gains + All Student Losses = Numerator
All Student Entries + All Student Gains = Denominator
Divide the Numerator by the Denominator to get the percentage of Mobility

TEACHING FACULTY ATTENDANCE

Directions: Teaching faculty attendance should be reported as a percentage and should include the school's total teaching faculty. The percentage should be calculated for the entire school year. The total number of teachers assigned to the building should reflect the number of teachers "home-based" in the building. Teachers who are assigned to the campus for part-time responsibilities, but who are not home-based at the campus, are not to be included in the calculation. Teachers who were not present, but who were engaged in professional activities off campus, are not to be counted in this calculation.

Example: 180 days in the school year X the number of teachers assigned to the building = total possible number of days attended by all teachers. The total number of teaching faculty absences for the school year divided by the total possible number of days attended by all teachers = the percentage of absences. 100% minus the percentage of absences = the percentage of teaching faculty attendance.

VOLUNTEERS
